Scope of the study program

The study program covers the core subjects of advanced Business Economics and Management through obligatory and elective courses. The objective of the course is to provide students with an advanced education in Macro- and Microeconomics, Business Economics and Management for a global market and economy, to enable them to apply these concepts, principles and techniques to a variety of business situations, to encourage them to think critically and independently with regard to intercultural management problems and to provide them to develop the skills and attributes necessary for their career and personal development.

Profile of a graduate

The doctoral study program in Business Economics and Management focuses on getting knowledge and on student's own contribution to it as a result of study research in the broad areas of Business Economics and Management. Besides the Macroeconomics, Microeconomics, Business Economics and Management, which form the core of the study, students may enroll in elective courses according to the title of their dissertation. There is a variety of elective courses – Strategic Management, Marketing Management, Financial Management, Business Financial Analysis, Project Management, Total Quality Management and others. Stress is put on implementation of Mathematical and Statistical Methods in Business Decision Making. A graduate should find his/her position in top managerial positions in business sector, international organizations, research institutions and universities.

Requirements on applicants

An applicant is required to have completed the master study at the university. All applicants must pass entrance exam - written (Macro- and Microeconomics and Foreign Language) and oral (Business Economics and Management).

Faculty at the study program

Core lectures, seminars and consultations are held by selected lecturers from the Department of Business Economics and Management, Department of Economics and Department of Quantitative Methods and Informatics. PhD thesis are devoted to students's interest in theoretical areas of Business Economics and Management as well as to application-oriented problems.
