#### **Contents of the training program**

Our doctorand study represents a self-startered program fastening onto the specialized ethical study, onto certain theoretically- analytical application knowledge and skills acquired in master's degree course. It provides a specifical scientific preparation of experts in ethics who are needed in the jobs requiring theoretical experience in a research sphere as well as in practical philosophy, resp. in subjects with an interdisciplinary approach. Except of compulsory subjects doctorands would have to choose also the optional ones with extra-ethical character offered by other workplaces at home or abroad. Their choise

must be in accordance with their professional aim and position status relating to the doctorand individual plan to meet a specific interdisciplinary requirement.

#### Profile of a graduate

A doctorand masters research scientific methods in the field of ethics and applied ethics, he/(she) can orientate well towards conceptions of ethical theory , methodology of sciences in praxis, follows the latest scientific trends in this discipline, goes in search of new original solvations an approaches in relation to an actual ethical problems. He cooperates with professionals in other scientific fields, he is able to apply his knowldge in praxis, he can manage a research in given area. A graduate — as an ethical expert will be able actively to cooperate with a top management of modern institutions, organizations, firms. He can identify and evaluate moral dillemas in regard to a subject of universal interest as well as to organizational level, he can propose systematic measures to prevent non-ethical behavior.

## Terms for applicants of applied ethics

An applicant of our doctorand study must be graduated from master's study of ethics or of related programs coresponding with ethical application, resp. he/(she) is a graduate of master's study in the field requiring interdisciplinary solution in an aspect of ethics or its application.

### **Educational status and skills of graduates**

- a doctorand masters research scientific methods in the field of theoretical ethics and ethical application, he/(she) has got sufficient knowledge related to conceptions of ethical theory, methodology of sciences in praxis, he can apply inter- and transdisciplinary approaches within scientific and theoretical strategies, follows the latest scientific trends in this field, searches new original solutions and approaches in regard with application and institutionalization of ethics in praxis
- he can evaluate moral problems of universal social interest and offer professional solutions towards top-ranking public institutions
- he is able to work activelly in a role of an ethical expert as an advisor, lecturer or trainer directed at social integrity and moral development, to form and develop organizational ethical policy, to

participate activelly at an introduction of ethical infrstructure, firm culture, social responsibility, etc. He can evaluate legally-social, personal, socially-economic and environmental linkages within ethical decisions in praxis, identify conflict situations and suggest effective solutions to prevent undesirable behavior

- he can educate another scientific and pedagogical workers in the field of ethics and applied ethics.
